TERMS AND CONDITIONS

Program Overview:

The Myoma Dunes Mutual Water Company Turf Rebate Program aims to encourage residents and HOA's to replace their water-intensive lawns with more water-efficient landscapes. The program offers rebates to eligible participants who replace their turf with drought-tolerant plants and permeable landscape surfaces. Projects are reviewed on a first-come, first-served basis. If you begin or complete your project before applying and receiving pre-approval, your project is not eligible for a rebate.

Eligibility:

- Participants must be an authorized owner or manager for a property within the Myoma Dunes Mutual Water Company service area.
- Participants must have an existing lawn that they wish to replace.
- Projects completed starting July 2022 may be eligible for a rebate if all proper supporting documentation is provided.
- Must be a minimum of 50 square feet, up to a maximum of 2000 square feet for Residential and up to 5,000 square feet for HOA's.
- Participants must replace grass with a combination of desert-friendly plants and permeable landscape surfaces.
- Participants must apply and receive approval from the program prior to beginning the project.
- Artificial turf or concrete or other hardscape projects are not acceptable.

Rebate Amount:

The rebate amount will be based on the square footage of the lawn being replaced and the type of water-efficient landscape being installed. Rebates funds are available on a first-come, first-served basis. Rebate funds are reserved for each customer at the time the application is submitted. The rebate amount will not exceed the total cost of the turf removal. Rebate checks will be issued for completed application projects only.

The rebate amount is \$3 per square foot of grass replaced, up to 2,000 square feet upon inspection for Residential and \$2 per square foot of grass replaces, up to 5,000 square feet upon inspection for HOA's.

Program Guidelines:

- Participants must submit before and after photos of the project along with proof of purchase and installation costs.
- Participants must notify us once pre-approved projects are finished.
- Participants must schedule inspections before and after project completion.

Application Process:

- Participants must submit an application to the Turf Rebate Program including a project plans, current photo of project area and a W-9 form.
- Program staff will review the application and notify the participant of approval or denial within 30 days.
- Approved participants will have 90 days to complete the project.
