

## A. METERED SERVICE CHARGES

### 1. FIXED METER CHARGE (per month by meter size)

#### Indoor Budget calculation –

Census Average Number of People in Homes (2.8 or customer validated occupancy count), Multiplied by 55 Gallons/Day/Person, times the number of Days in the Billing Cycle. The State has mandated a 50 Gallons/Day/Person by the Year 2025.

#### Outdoor Budget Calculation –

(Lot area) x (0.62) x (ETO) x (California Conservation Reduction factor) / (gallon to CCF)

Lot Area - The square feet of the lot obtained through county records

0.62 - Conversion Factor to gallons per square foot

ETO - Evapotranspiration rate per CIMIS Station 200 (Indio 2) billing period total

California Conservation Reduction factor - .70 (70%)

gallon to CCF - Converts gallons into billing units (1 unit = 748 gallons)

Facility Impact Fees on meters 3 inch or larger will be determined on a case-by-case basis by the General Manager. The Facility Impact Fee will be based on an estimate of the average annual usage in ccf for a similar building classification with the same size meter. The estimated annual average usage in ccf will be multiplied by the current Tier 4 Rate to determine the Development impact fee payable.
